



Privacy Policy of www.coldorcia.com website

Welcome to www.coldorcia.com website . This website is handed by COL D'ORCIA S.r.l. Società Agricola, Via Giuncheti 53024 Montalcino – Italia, that acts as Holder of treatment. According to Article 13 Italian Legislative Decree N. 196 of June 2003 concerning the processing of personal data related to the visiting of our website.

Place of data processing: All the processing related to the collected data takes place at COL D'ORCIA's registered office or with operating system partners chosen by COL D'ORCIA.

Type of data processed

- browsing data

The operating system and browser software in charge of the website host some data whose transmission is implicit in using the Internet protocol of communication. This information is not collected to be associated with any particular identified interested, but in view of their character, may interact during processing or be associated with third parties, allowing to identify the users. In this category of data are included the Internet protocol (IP) address of your computer, the domain and host from which you access the Internet, the Internet address of the site from which you linked directly URL (Uniform Resource Identified), the time of the request, the method used to submit the request to the server, the dimension of the answering file, the code number indicating the positive/negative answering result of the server, and other standards related to computer system of the user.

All these data are used to extract statistical and anonymous information on the website use and to control its correct functionality. The data could also be used regarding hypothetical theft or some other form of unauthorized use.

The website does not use persistent cookies, but only session cookies, closely linked to the transmission of each session identification, generated by the server system and required for the correct browsing. Session cookies are used instead of other computer methods, considered prejudicial for users right to privacy, and they do not collect personal identified information from website users.

- Data given by the user in active form

In case of requirement to collect personal data from users, an appropriate informative is provided, and where necessary, consent is requested.

Procedure for processing browsing data.

Personal data collected during browsing is processed by computer system only for the time related to the purpose of their collection.

Security measures are taken to prevent loss of data and to protect against unauthorized use and access. Such data is not transmitted to third parties.

Rights of the users:

The user has the right to obtain the confirmation of the existence of personal data, and to know that such data is available in intelligible way. It is also in his rights to ask the origin of the data, the updating, the rectification or, if it is in his interest, the integration of the data; he can also obtain information about to whom the data was communicated or processing that took place. The user can obtain the cancellation of the block of data processed in violation of law, and make opposition to its further processing.

After the request of cancellation of personal data, the user will receive confirmation that the cancellation has taken place.

The user can exercise his rights addressing directly Col d'Orcia.
